LUVERNE PUBLIC SCHOOL DISTRICT EDUCATOR HALL OF FAME

The Luverne Public Schools Educator Hall of Fame is organized as a way of maintaining the rich heritage and tradition of successful academic, extra-curricular, and operation of Luverne Public Schools and the effect educators have on the community in general.

The Luverne Public Schools Educator Hall of Fame honors the contributions and accomplishments of these individuals who are worthy of recognition as examples for others to emulate.

NOMINATION PROCESS AND PROCEDURE:

Nominations shall be accepted from January 1st to April 30th annually.

Nominations may be made by alumni, current or former faculty and staff, administrators, interested parties and community members of Luverne Public Schools.

Completed applications must include:

- Complete application (which follows)

- Three letters of support from appropriate individuals who can validate or substantiate pertinent information related to the nominee.

- If available, a limited number of newspaper clippings, magazine articles, copies of scorebooks and statistics may be included to help substantiate the accomplishments and contributions of the nominee.

- If available, a suitable photograph(s), preferably black and white, for reproduction should be submitted.

CRITERIA:

Nominees must exemplify the highest standards of ethical conduct and moral character.

All candidates will be judged on their significant and/or long-term contributions to Luverne Public Schools and the Rock County community.

Nominees must have been employed as full-time staff (administrator or educator) within the Luverne Public school system for minimum of 8 years and must have distinguished themselves by demonstrating exceptional leadership, character and achievement during his/her tenure in the Luverne Public School District.

The nominee must be retired from or not working for the District for a minimum of 5 years.

The inductee may be either living or deceased.

SELECTION PROCESS:

The Luverne Public Schools Administrator & Faculty Hall of Fame Committee will review the applications annually following the closing date.

The application will be reviewed for references and history to ensure satisfaction of the Hall of Fame requirements and qualifications.

Nominations need only be made one time. Those not selected will be retained for future consideration.

All nominators will be informed of the selection of inductees.

The annual induction ceremony is planned for the fall of each year during the weekend of the Luverne High School Homecoming Football Game.

RECOGNITION:

Inductees will be recognized with their name and induction year on a plaque located on the Luverne Public Schools campus.

Inductees shall also receive a personal recognition award.
